Estate Planning

Determining the right gift is just as important as making the gift. There are many options in your estate planning from which you can choose. In general, one of the simplest methods to leave a lasting legacy to NAECTEF is the bequest. Bequests are an instrument of a contributor's will that sets aside, at death, a sum of money, a portion of the estate, or a portion of the estate's residuary for distribution to a charitable organization such as NAECTEF. The bequest can be small or large. It can be unrestricted, or it can be restricted for use to a specific program of interest.

Wills and Living Trusts

By including NAECTEF in your will or living trust, you can make an important and lasting gift to early childhood teacher education, while meeting your financial and estate planning goals. A bequest to NAECTEF can take many forms, and because a bequest qualifies for the estate tax charitable deduction, it may reduce your taxable estate.

Common types of bequests: *These are three generally accepted ways to make a bequest. You might discuss them with your financial planner or your attorney as you prepare to update your will.*

General: "I give to the National Association of Early Childhood Teacher Educators Foundation, a corporation organized and existing under the Texas Nonprofit Corporation Law, headquartered at 4223 Shady Bend Drive, Dallas, Dallas County, Texas 75244, the sum of _____ dollars to be used as the NAECTEF Governing Board of Directors directs."

Bequest of a percentage: "I give and bequeath _____ percent (name specific percentage) of my estate to the National Association of Early Childhood Teacher Educators Foundation, a corporation organized and existing under the Texas Nonprofit Corporation Law, headquartered at 4223 Shady Bend Drive, Dallas, Dallas County, Texas 75244."

To leave a gift from a Living Trust, write: "I direct my trustee to distribute from the principal of my trust estate to the National Association of Early Childhood Teacher Educators Foundation, a corporation organized and existing under the Texas Nonprofit Corporation Law, headquartered at 4223 Shady Bend Drive, Dallas, Dallas County, Texas 75244, the sum of _____ dollars." (or a percentage)

Retirement Plan Assets

Your IRA, 401(k), 403(b) or other qualified retirement plan may be heavily taxed if left to anyone other than a legally recognized spouse. By naming NAECTEF as a beneficiary of all or a portion of a retirement plan, you avoid both the estate tax and income tax due on these tax-deferred plans than if you distributed the proceeds to your heirs.

A little planning today can ensure the thoughtful disbursement of your assets and can assure that you, your heirs, and your charitable interests have a more secure future.

Workplace Giving: Have your money go twice as far by getting a match from your company, institution, or university!

You can help NAECTEF by finding out if your company, institution, or university has a Corporate Giving Program or Foundation. Many companies match funds for volunteer hours or employee donations. Companies often concentrate their grants or matching gifts on specific areas such as children or education. As you know, NAECTEF has several initiatives that may meet their criteria — initiatives such as our support for research in early childhood teacher education and scholarships for potential early childhood teacher educators.

If your company has such a program, remember to send in a matching form with your donation next time you give to NAECTEF. If you are uncertain whether your company has such a program, find out now for the next time you donate to NAECTEF. Your company's HR Department should be able to provide you with the form or know if such a program exists.
